Case Management: Assess the needs of an older individual; develop a service plan to meet the needs of the individual and monitor the delivery of services.	
Congregate Meals: A nutritionally balanced meal provided in a group setting.	
Elder Rights: Elder abuse assessment & intervention- service to assist an individual at risk of or experiencing abuse, neglect, or financial exploitation.	
Family Caregiver Counseling: Provide counseling to caregivers to assist them in making decisions and solving problems relating to their caregiver roles.	
Health Promotion/Evidence-Based: Monthly educational materials, presentations, and activities promoting better health and wellness.	
Home Delivered Meals (Nutrition): Nutritionally balanced meal delivered to the residence of homebound individuals.	
Information & Assistance: Provide an individual with current information on services available within a community.	
Legal Assistance: Legal advice and representation provided by an attorney to older individuals with economic or social needs.	
Options Counseling: An interactive process where individuals receive information to make informed choices about long-term supports.	
Nutrition Counseling: Provides individualized guidance to individuals who are at nutritional risk.	
Nutrition Education: A targeted program provided monthly to all congregate and home-delivered meal participants to promote better health by providing accurate and culturally sensitive nutrition, physical fitness, or health as it relates to nutrition information.

Adult Day Care: Service provided to adults who require care and supervision in a protective setting for a portion of a 24-hour day.	
Assisted Transportation: Provides or arranges for the travel, including travel costs for the individual from one location to another. Could also include assistance in and out of the vehicle.	
Behavioral Health Support: Mental health outreach services to an older individual within the community.	
Chore : Performance of heavy household tasks provided in a person's home and or yard.	
Emergency Response System: A service provided to a consumer that includes the installation of and monthly fee for an emergency response system.	
Home Maker: Performance of light housekeeping tasks provided in a person's home and assistance with errands.	
Material Aid: Provides services or goods to promote safety at home.	
Outreach: Provision of one on one interventions initiated by an agency or organization to identify potential consumers and encourage their use of existing services and benefits.	
Personal Care: Assistance with Activities of Daily Living/and or health-related tasks.	
Family Care Giver Respite Care: Service which offers temporary, substitute supports or living arrangement for care recipients to provide a brief period of relief or rest for caregivers	
Family Caregiver Support Groups: A service to facilitate caregivers to discuss their common concerns related to caregiving and provide mutual support to each other.	
Training and Education: Activities meant to impart knowledge, experience, or skills to an individual or group regarding AAA services.	
Transportation: Services or activities that provide or arrange for travel, including travel costs, for individuals from one location to another. Does not include any other activity.
